Objectives – Following this course, participants should be able to:

1. List the four core competencies of Interprofessional Education (IPE)
2. Integrate the principles of cultural humility into IPE and analyze the impact of social determinants of health on collaborative care
3. Identify appropriate virtual communication methods for facilitating a small interprofessional group
4. Apply appropriate debriefing techniques for both in-person and virtual IPE activities
5. Create four structured debriefing questions, each intentionally aligned with a distinct IPE core competency
